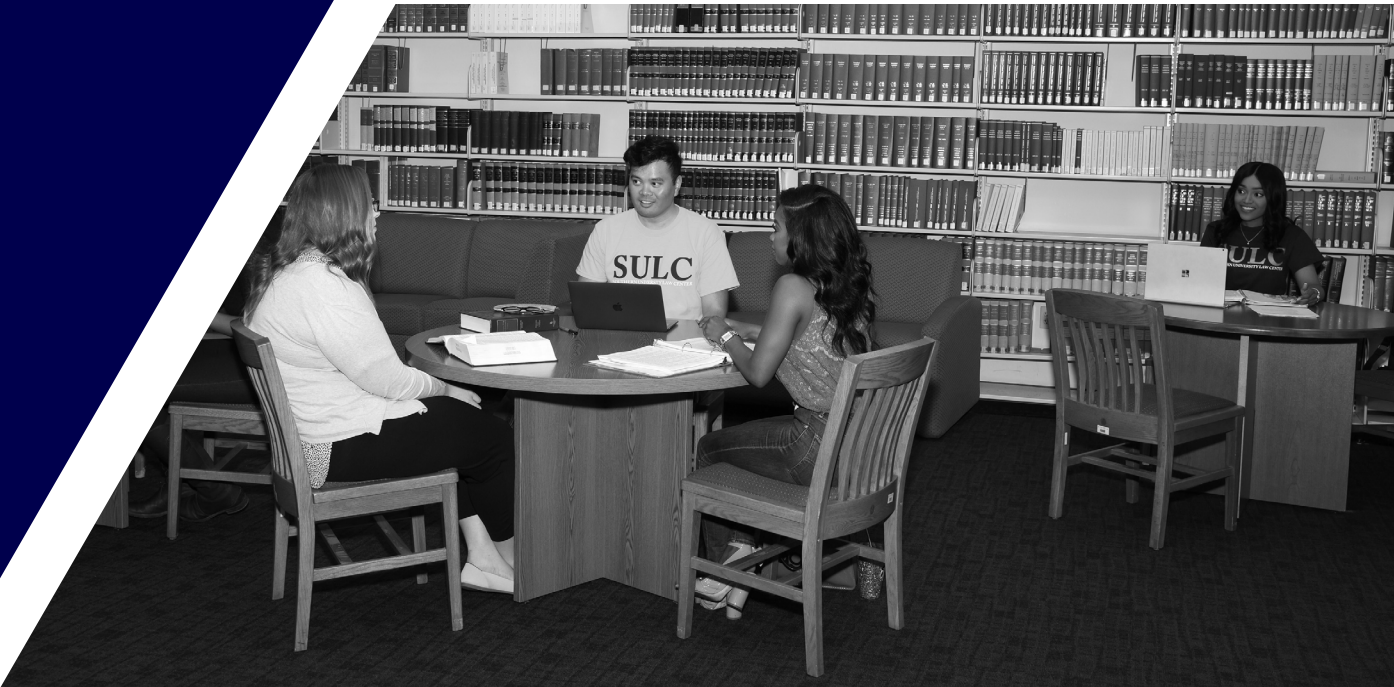

The Law Center held an in person and virtual joint panel with the LSU Law Center to discuss the impact of Charles Hatfield's lawsuit that resulted in the establishing of the Law Center. Panelist included Evelyn Wilson, LSU professor; Eric Hatfield, Law Center alumnus and grandson of Charles Hatfield; Jake Henry, assistant dean of student affairs at LSU Law School; and Kenn Barnes, attorney. Each panelist gave background on the rich history of the Law Center and its connection to the LSU Law Center.

SULC AND SUAREC HOST THE 2022 CANNABIS SYMPOSIUM

Southern University's Baton Rouge landmass was the first stop for Green Enterprise's College to Career initiative tour. The series of on-campus events brought together entrepreneurs, state officials and thought leaders to discuss solutions to create a point of entry in the emerging cannabis industry, as well as meaningful pathways to success.

Topics covered during the symposium included the State of Louisiana's Medical Marijuana Program, the Business of Growing Medical Marijuana, Cannabis and the Endocannabinoid System, Southern University's Cannabis Research Initiatives, Equity and Justice, the State of Louisiana's Hemp Program, International Cannabis Law, Cannabis Pharmacology, and a Roundtable discussion of Hemp Growers.

The event also featured a Hemp Growing 101 session which provided participants with hands-on training.

Deleso Alford, J.D., LL.M is the Rachel Emanuel Endowed Professor of Law, Southern University Law Center and Off-Campus Instructional Site (OCIS) Director at Shreveport Memorial Library (Shreveport, Louisiana). A proud SU and SULC alum, Professor Alford also earned a LL.M. from Georgetown University Law Center and a Certification in Clinical Bioethics from the Medical College of Wisconsin. Professor Alford's scholarship focuses on what she refers to as "HER stories"—the unique and particularized lived experiences of black women intersecting with health care and research. She has moved her scholarship into classrooms, benefiting both law and medical students with her racially inflected lessons.
