SULC WELCOMES NEW STUDENTS AT ANNUAL COMMITTED STUDENTS' DAY EVENT

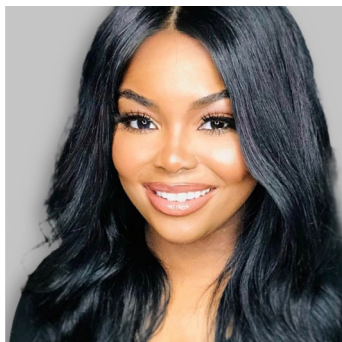

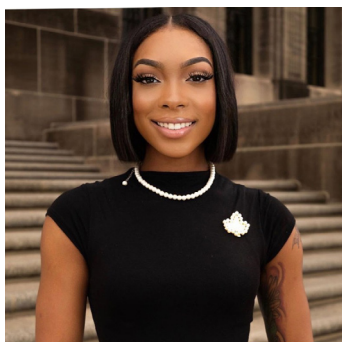

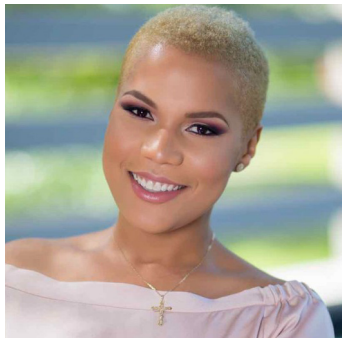
